TERMS & CONDITIONS FOR SERVICES OFFERED:

Any employers throughout the country can avail our services subject to the fulfillment of Terms and Conditions for services offered. The employers can send us their requirements through email (himnaukri@gmail.com). The receipt of requirements will be treated as an acceptance of our terms and conditions.

1. Being aware of the rising level of unemployment in the state, **Himnaukri doesn't charge even a single rupee from any of the Job seekers, candidates for getting them placed in our client companies.**
2. As an accepted norm in the Indian placement industry, the placement consultancies charge the employers 8.33% of the CTC offered by them to the candidates for a specific profile. 8.33% of CTC normally is equivalent to one month salary of the candidate. Whereas, we charge only an amount equal to 50% of the one month salary of the candidate.
3. HimNaukri provides free replacement of candidates in case the candidates leave the job before completion of 45 days in a specific client organization.
4. We expect to receive our payments within 15 days of the candidate's selection via NEFT.
5. HimNaukri simply acts a bridge gapping the gorge between employers and job seekers. We just inform the candidates about the available job opportunities with our clients. The selection process is the overall responsibility of the organization (employer). HimNaukri does not assume any liability, whatsoever may arise, as a result of the selection of a particular candidate.
6. HimNaukri will not be responsible for any dispute between the employer and the employee. We will not be responsible for any misconduct, misbehavior or misleading criminal record of the candidate, whatsoever, as our responsibility ends as soon as the employer meets the potential employee.
7. The organization (employer) should by themselves, verify the authenticity, eligibility, identity of the candidates before recruiting them as employees.
8. The client organization (employer) is required to inform us about the number of selections made, out of total candidates that appeared for the interview, based on the information propagated by us.
9. If the candidate referred by us is not selected and we get to know that the person is working with your organization within 12 months of the date of interview, it will be considered to be a placement made by HimNaukri and the organization (employee) will be liable to pay the requisite charges.
